
Advocacy and the American Medical Association

Publications & Journal Update

The SAGES Publications committee is happy to announce that our journal, *Surgical Endoscopy*, has experienced immense growth over the past year. Please see below for our highlights.



- SE's 2020 Impact Factor of 4.584 is its highest ever
- SE currently ranks 33rd out of 210 surgery journals tracked for an Impact Factor
- Google ranks SE as 5th among surgery journals in its H5 Index
- 2,777 submissions through Nov 11 which is on pace to surpass 3,000 submissions this year for the first time
- 2020 was the first year with 1 million + downloads. Through Oct 31, SE has already exceed 1 million again as we are on pace to surpass 2020's record
- 91% of authors rate their experience with SE as either Good (26%) or Excellent (65%)
