# **Island Hopping**

t is winter in Chicago and in these and other northern climates, the islands we often think of are of the tropical variety. The image of a sand beach and azure sea bedazzled by sun is a welcomed refuge from the sullied snow and windborne chill that whips Lake Michigan into a front of frozen grey. John Donne, the early 17<sup>th</sup> century British poet and preacher, knew of chill and meager times. The island metaphor he recounts in his oft quoted Meditation XVII (*Nunc lento sonitu dicunt*, Morieris) has a more somber strain than a winter fantasy of fruit drinks and festival: "No man is an island, entire of itself, every man is a piece of the Continent, a part of the main."

Donne linked the individual and the community, the specific and the general, as inseparable components of the human condition. It seems to me, in this grand new year of 2006, that this very concept applies to modern medical societies. As knowledge and technology race headlong in pursuit of disease processes, the distinction between physicians who treat similar conditions as different specialists becomes increasingly blurred. The natural evolution is collaboration as we decipher the best way to attack a common enemy with our ever expanding arsenal of molecular and mechanical tools.

SAGES is proudly on the crest of numerous collaborative pursuits. Perhaps the most acute example is the mergence of minimally invasive surgery and endoscopy. In March, SAGES and the American Society for Gastrointestinal Endoscopy (ASGE) will jointly host the first International Conference on Natural Orifice Translumenal Endoscopic Surgery (NOTES). This meeting will bring together gastroenterologists and surgeons, teams of experts in flexible endoscopy and laparoscopic surgery from

around the world to explore the challenges in bringing translumenal endotherapy to the clinical realm. In another specialty-spanning effort, SAGES and the Minimally Invasive Robotics Association (MIRA) will sponsor the Robotics Guidelines Writing Consensus Conference in June. In these and in other timely endeavors, the citizenry of practitioners from multiple professional islands are linked.

It is a natural consideration that professional organizations might open ports of membership to their colleagues who, although of different brand, are like-linked in battle: call it island hopping if you will. To this end, SAGES Board of Governors has approved an amendment to the society's by-laws that would open the Associate Active membership category to "non-surgeon" gastrointestinal endoscopists with specific qualifications. This amendment must yet be voted on by the general membership and is no doubt controversial for some. From my vantage, this proposal will in no way compromise our identity and can only strengthen SAGES ability to influence the evolving challenges of caring for patients with GI afflictions.



# Sustainable Growth Rate And Pay for Performance — A Surgical Perspective

Surgeons are currently faced with two factors which do or will affect our reimbursement – the Sustainable Growth Rate and Pay for Performance. The Sustainable Growth Rate refers to the speed at which Medicare is allowed to up or downgrade medical costs, including fees. The increases have to be balanced against decreases for an essentially zero increase in Medicare spending year to year.

Pay for Performance refers to a plan that will financially reward physicians who practice within parameters, which are yet to be announced, and financially punish those who don't. It may amount to a difference of only 0.5% to 2.0% between the two groups, but this can be significant. Currently we are not certain that there are good tools to factor in acuity of care. We all know that there may be vast differences in the management of patients with the same condition based on their level of sickness.

That being said, physicians can make an impact on the Sustainable Growth Rate problem. The government plans to maintain the SGR and push forward with Pay for Performance (P4P). This has the potential to lead surgeons down a road of opposition with other physicians and will result in draconian Medicare cuts to the tune of 26%.

The first step in this downward spiral begins with a 4.4% decrease in Medicare payments in 2006. This single cut may cause physicians to limit the number of Medicare patients they accept or cause them to drop out of Medicare completely. An AMA survey showed that 38 percent of physicians will decrease the number of new Medicare patients they accept due to this first Medicare payment cut. And that is just the beginning; further cuts are scheduled to come after 2006.

The survey results show additional practice changes physicians will be forced to make as a result of the cuts. For example, if Medicare payments are cut by about 5 percent in 2006, 61 percent of physicians plan to defer purchase of new medical equipment and 54 percent plan to defer purchase of information technology. This is alarming because the entire future of health care is based on technological and informatics progress and application.

Actually, when it first started, P4P was locked arm-in-arm with Congress, dropping the SGR. This would allow for increases not to be budget neutral (currently an increase in one area of medicine means a decrease somewhere else in order to maintain budget neutrality). This concept was widely embraced

by surgeons as this marriage (P4P and SGR) would allow for a more reasonable fee structure. Additionally, it fostered the development over time of a quality system which could improve parameters of care globally. We all began working towards those goals.

Then hard reality set in - compliments of Washington.

Government claimed that there was not enough money to accomplish removing the SGR. Excuses included hurricanes and war. Congress and the Senate decided to keep the SGR in place and still pursue P4P. All of this major decision-making has been done in a period of weeks, not a lot of time to spend discussing the future of health care for our elderly (as we all know, many other insurers follow the lead of Medicare, which translates into a bad plan for healthcare nationwide).

Congress has floated a plan that will give surgeons all a 1% raise if we will go along with SGR and P4P. One percent does not even cover inflation in health care costs over the past year and leaves us wide open for the continuing cuts in the years to follow. However, there is no remedy in place for the 4.4% decrease in 2006 and the 26% decrease over the next six years.

There also is the unaddressed problem of the underachievers under P4P who will lose more financially, many times because of situations over which they have no control, such as the advanced state of disease the patient faces and problems with adequate hospital staffing. The American College of Surgeons has an excellent position paper on the issue of P4P posted on their web page, and if you read carefully, you will see that once again, the surgical community has taken the lead and essentially completed Phase I and Phase 2 of the program. Phase I and 2 were simple quality goals, such as surgical site marking and pain management tools. Only Phase 3, the financial phase, remains for implementation with a scheduled take-off in 2006. I believe that this phase will be under the control of the CMS.

AMA Board Chairman Duane M. Cady, MD, FACS told members of a key House subcommittee that the AMA strongly urges Congress to enact at least two years of positive payment updates (increases in Medicare payments), giving Congress time to enact a long-term solution while preserving seniors' access to care in the short term.

Frank Opelka, MD, FACS, a member of the ACS Health Policy Steering committee, also testified to the subcommittee on behalf of the American College of Surgeons. Dr. Opelka expressed the College's concern that the 4.4 percent cut in Medicare payments, which went into *Continued on page 11*.

### Outcomes

The SAGES Outcomes Initiative reached its record 20,000th case on December 7, 2005. The program continues to expand and is in the process of rolling out an EGD registry as well as a Pediatric registry, in conjunction with the International Pediatric Endosurgery Group (IPEG). Other modules in development are robotics and an appendix registry. The new PDA software is available for current participants. ### Flexible Endoscopy

# FLS Continues to Spread Its Wings From the Military to Down Under

The Fundamentals of Laparoscopic Surgery (FLS) program is continuing to gain momentum in the surgical community, and has recently received great support and recognition from the Military and Australia. The National Capital Area Medical Simulation Center of the Uniformed Services University of the Health Sciences (USUHS), in conjunction with the TriCare Management Agency, is embarking on a project to improve skills, communication and patient safety in minimally invasive surgery by introducing the FLS curriculum to all military hospitals with surgical training programs. This program will include a series of lectures based on slides produced from the FLS CDs, followed by mentored, proficiency based practice on the FLS trainer box. Upon completion of this course, military providers will have the opportunity to take the FLS written and skills tests to become FLS certified. Military surgeons or program directors interested in this program or in incorporating FLS into their curricula should contact Dr. E. Matt Ritter at eritter@simcen.usuhs.mil.

Also in recent news, Lisa Jukelevics, FLS Project Manager, traveled down under to begin negotiations with the Queensland Health Skills Development Centre (SDC) in Brisbane, Australia and the Royal Australasian College of Surgeons (RACS) to work on a strategy for the implementation of FLS throughout Australia and New Zealand. An introductory workshop, facilitated by Lisa, was attended by eighteen leading surgeons from Australia and New Zealand. Attendees also included Dr. Russell Stitz, President of RACS and Kathleen Hickey, Director of Surgical Skills Training. The course was welcomed as a validated and well developed laparoscopic training module with the expectation of becoming the primary course and building block in surgical simulation and training throughout Australia, New Zealand, and eventually Asia Pacific. SAGES and ACS will work closely with the SDC under the auspices of RACS and the Board of Surgery to ensure the integrity of the FLS program and examinations remain. While the educational underpinnings and structure of this plan is still in the beginning stages, we're all very excited at the prospect of integrating FLS on such a grand scale.

A new FLS brochure featuring the recent partnership of ACS, new FLS Test Centers and Educational Packages are now being printed and a new FLS Newsletter will be distributed quarterly by e-mail to its subscribers. The FLS website, www.flsprogram.org, will have a new look and include infor-


# First SAGES Foundation Tribute Dinner to Honor Ken & Kay Forde

And Celebrate SAGES 25th Anniversary Kay & Dr. Kenneth Forde

he SAGES Education & Research Foundation will host its first annual Tribute Dinner during the 2006 Annual Meeting in Dallas next April. The dinner will take place on Thursday Evening, April 27th. Kenneth and Kay Forde are, in many respects, two of the parents of SAGES. The Foundation, in establishing the annual event, wanted to salute the luminaries who have provided the framework on which SAGES and endoscopic surgery have been built.

affect January 1, will have negative effects on surgeons' ability to practice and on Medicare patient access.

Clearly, these two issues, SGR and P4P, have been intertwined and need to be separated for political action. P4P will not be an answer to reducing Medicare costs. The administrative costs of creating and running P4P will be gargantuan. The effect on our relationships with our colleagues will be immense. Remember, in the SGR environment, there are financial winners and losers among our colleagues and ourselves, simply because the budget must be balanced. Adding P4P, which creates even stronger financial differentials, will most likely make professional schisms deeper.

At the AMA meeting in June, delegates were asked to call our Senators and Representatives to discuss our displeasure with the SGR and P4P. Over five hundred people made over 1500 phone calls in a few hours to their Senators and Representatives and created a real awareness of our position. This type of effort can be related to shelling an island to soften

it up before an invasion. Such efforts make it easier for our lobbyists to gain access and entree to relevant Congressmen and Representatives. This is a powerful way to convince our politicians to do what's right and is clearly in the American political tradition.

Now is the time for SAGES members to take action. There are only a few short weeks to resolve this issue. Without <u>all of us</u> acting in a positive manner, we will certainly garner a 4.4% Medicare decrease which will filter down through all of our insurance fee schedules.

societal collaborations on other fronts. With the American Society of Colon and Rectal Surgeons (ASCRS), we have recently issued guidelines for the laparoscopic resection of colorectal cancer and for training courses in laparoscopic colectomy. In triple force with the ASCRS and the ASGE, a comprehensive document on bowel prep prior to colonoscopy has been developed. This April we will again feature Surgical Spring Week, as the American College of Surgeons (ACS) and the International Pediatric Endosurgery Group (IPEG) join SAGES at the same Dallas venue. In addition to SAGES usual outstanding scientific sessions and postgraduate courses, this meeting will showcase collaborative educational offerings with the ACS, IPEG, ASCRS, MIRA, ASGE, The Fellowship Council and The Society of Laproendoscopic Surgeons (SLS). Our society is

also fortunate to continue its close relationships with our fellow societies in GI surgery, the Society for Surgery of the Alimentary Tract (SSAT) and the American Hepato-Pancreato-Biliary Association (AHPBA), to explore educational opportunities for the mutual benefit of our members.

The archipelago of medical organizations has many separate atolls but they are inextricably linked. SAGES is a productive and sought after collaborator.
